# FROM THE DIRECTOR'S DESK

The normal December meeting of the SCCA Board of Directors took place December 7-8 in Denver. While I will cover the events of that BoD meeting, there are some even more important happenings here in CenDiv, and we need to talk about those first.

## **CenDiv Schedule for 2002:**

The racing schedule for the coming year is usually set at the Central Division Roundtable meetings in early November. I have expressed for a number of years that I believe the CenDiv racing schedule is a mess. There are simply too many races scheduled too close together. I have had numerous drivers and workers complain to me across the past several years. The drivers feel that there are too many races that they must make in order to compete for either the Regional Champ Series championship, the CenDiv National Series points championship, or a Runoffs invitation. Workers complain that they are being asked to spread themselves too thin to work all the events, and that worker "burn out" is the result. In fact, across the past two years an increasing number of events have been cancelled due to lack of either workers or entries. In one case an event was even cancelled in the middle of the weekend. Well, it came to a head at this year's Roundtable, when an expansion in the number of National Races requested by the regions created a situation that was in violation of GCR scheduling requirements. The Regional Executives at Roundtable asked Area 5 Director, Ken Patterson and I to request a waiver from the BoD. This waiver was denied, thus placing the whole CenDiv schedule on hold. The BoD also reviewed the concept of a Scheduling Council which had been drafted by some of the folks at Roundtable as a means of resolving such conflicts and bringing the CenDiv schedule back under control. The BoD chose not to act on the proposal, feeling that the division should govern itself, without BoD interference. So Ken and I brought the situation back to the RE's of the racing regions in a series of conference calls aimed at working out a 2002 CenDiv schedule before the end of the year. The alternative was that spring could arrive and the opening events in both the National and Regional series could fail to occur due to the unacceptability of the overall schedule. The results of the calls were that several regions have agreed to co-

operate together on National Races rather than each run their own, and the division as a whole has agreed to permit one of the events to be a double National. Double Nationals require approval by 75% of the regions, and despite several previous attempts to schedule one, division-wide cooperation had never been achieved.....until now. In an effort to salvage the start of the 2002 CenDiv season, the RE's managed to work together to resolve the conflict with a series of compromises. Furthermore, the RE's agreed to sit down at the spring CenDiv Race Officials meetings and work toward some version of the proposed scheduling council concept. Ken and I would like to thank everyone who helped to work through this situation and also to urge all the parties to follow up with a plan that will help keep this from happening again in the future.

## **2002 SCCA Officers:**

The SCCA BoD elected a new Chairman of the Board in the form of former CenDiv member, and current Southern Pacific Division Director, JoAnne Jensen. Gary Pitts of Northern Pacific Division was elected Vice-Chairman. Tom Campbell and Kathy Barnes remain as Treasurer and Secretary. The other big change is that Competition Board Chairman, Phil Creighton has been allowed to retire after a lengthy nine years on the Comp Board. We all want to thank Phil for his extensive service to the club and welcome the new chairman, Kurt Weiss.

## **2002 Insurance Rates:**

The BoD was asked to approve the insurance rates that regions will pay for events in 2002. Anyone who has priced insurance or renewed a policy in the wake of September 11<sup>th</sup> knows that insurance costs are going up. Our insurers are telling us the same thing. And the BoD was therefore asked to increase event premiums in a number of areas. While all the details will be forthcoming in the new Insurance Handbook, I need to forewarn regions that one of the changes was an increase in the Solo II premium from \$2 to \$3 per car. While this is only \$1 per car, it is also a

50% increase, and it generated much discussion on the BoD. Solo II is our primary entry level activity and I was one of several who argued that a fifty cent increase for 2002 would be a smarter move. However, the \$1 increase was ultimately approved. There is even worse news however, and that is that we can gain no guarantees about what rates are going to do in the coming year, and we need to be prepared that it is possible many of our programs may get hit with more increases next year.

## **Member Satisfactions:**

On a very positive note, SCCA membership is at an all time record high, and member retention has made a tremendous improvement. Many of you have heard me say at various meetings around the division that we should be ashamed of how many new members we lose after only one year. This turnover rate has frequently been in the 30% range, which is pretty abysmal. However, for 2001 membership losses have been at only 17%, a record low. SCCA President, Steve Johnson, and his staff have played an active role in trying to increase member satisfaction and a number of regions have also tried to improve their local communications with new members. The good news is, it's working. Let's keep it up! One of the

major areas of the automotive market place that we have been drawing from is the hopped-up import car segment. Solo II's Street Touring and Street Mod classes and Pro Racing's Speedvision World Challenge series have focused heavily on these folks, and the payoff in terms of new members is turning out to be huge. You might want to think about ways to approach this market segment in your local area.

**Revamping the Stewards Program:**

Those of you who know me are aware that one of my long time complaints was inconsistency in the rules interpretations and enforcement that come out of the stewards program around the country. Well, some recent situations added new emphasis to this, and the result was that the BoD earlier this year empowered a task force to review the stewards program and make recommendations. The results of that effort were presented to the BoD at the December meeting and after much discussion, the major recommendations were accepted. While roll-out of the whole program will not occur until the Convention, suffice to say that there will be major changes in the program and the intent is to address the

problems that I mentioned and that many of you have echoed to me in your calls and letters.

**SCCA Pro Racing:**

I will make no attempt to hide from you the fact that SCCA Pro Racing did not live up to it's financial goal for the year about to end. I could present a list of reasons, but the long and the short of it is, they didn't make it. The result was the need for them to request a short term loan from SCCA, Inc. in order to get through the winter and begin the new season. With increased income from several sources (including new externally created pro series which are coming to us for sanction and support) the cash flow projections show conservatively that this \$300,000 loan can be repaid during the course of next year. This was a major topic of discussion, and I will tell you that there were no less than four directors who refused to vote for the loan, including me. Having passed the measure, however, the BoD then needed to designate the source of the funding, and the leading choice was to tap into the funds from the sale of our former office building. These funds had been sequestered by the BoD when the

sale was finalized, and a 2/3 majority of the BoD was required to unsequester them for anything other than building purposes. This motion barely passed with the required 2/3 margin. Although this is not the position anyone hoped for from Pro Racing, the manner in which the motions were debated by the BoD should make it clear that patience has run out.

**SCCA Convention:**

Don't forget the upcoming Convention in Denver. The event will see the roll-out of the new Stewards Program, as well as the SCCA University concept that Steve Johnson has talked about. A number of excellent training sessions and seminars are planned, building on the outstanding event that we had last year. Plan to attend if at all possible. I strongly urge every region to send at least one representative.

**Club Racing Classes:**

One final important item of note. All of our National Racing classes managed to meet the 3.5 car average for 2001, so for the first time in several years, no classes are on probation for next year.
