#### iii. FSAE

#### a. Event Budgets

- i. Grand Prix

  - Discussion:
  - Ed Arthur the Indy Car folks said there was not enough shelter for our workers. Maybe get some umbrellas, for sun or rain. Will get with Bob Martin and Jerry Shiloff and Indy Car people.
  - Discuss at GP SCCA meeting. If more is needed, the budget will be resubmitted, but we need to approve this budget now to allow spending to start.
  - Need power cord on turn 8.
  - There is no SCCA sanctioned event this year so our fee will not be increased. However, it will be kept in mind for next year.
  - The budget was approved unanimously.
- ii. Rallycross, May 21 at Thistle Hill (Jon Jareo)
  - Entries will be limited to 55.
  - May have to limit non-competitors or a special license from South Lyon Township will be required (150 is their limit).
  - Motion to approve budget by Mike Nienhuis, seconded by Jeremiah Mauricio, unanimously approved.
- iii Rally, Moonlight Monte, June 18, West Branch, MI (John Fishbeck)
  - Motion to approve by Jen Glass, seconded by Jen Merideth. Unanimous approval.
- iv. Rally, Press on Regardless, Sept 10-11.
  - It will be a National Event this year. Bruce Fisher has organized this for over 10 years and continues to put on a great event.
  - Motion to approve by Jen Glass, 2<sup>nd</sup> by Jon Jareo, unanimously approved.
- v. Test and Tune, Oscoda, July 2-4 (Pat Barber)
  - Max entry will be 40 cars, with a minimum of 20 to break even. (No problem).
  - Motion to approve by Mike Nienhuis, 2<sup>nd</sup> by Jen Glass, unanimously approved.

John Kytasty and Ken Weidbusch were given the floor to review their proposal for the purchase of a new Race Trailer

Please refer to John's portfolio for the details.

#### At 7:25 A Question and Answer period was provided

- A question to the durability of the wire racks was raised by Fishbeck and Barber. Kytasty
  deferred to Bob Martin as the expert on these racks. The recommendation provided by Barber
  was to Limit the purchase to 1 unit until the durability could be validated. John Kytasty
  recommend that 2 be purchased to ensure proper (even) loading within the trailer
- A question regarding the use of Barn Doors was raised by Nienhuis. John Kytasty indicated that
  the unit will be built with a ramp door.
- A question regarding the disposition of the existing race trailer was raised. Kytasty and Weidbusch indicated that the current race trailer will become static storage replacing "Bob's" truck with is currently undriveable and is used for transient storage for both the Race and RallyCross equipment.
- A question was raised by Lisiecki regarding plans for graphics. John Kytasty indicated the current plan did not contain graphics and the trailer will be white.
- A question was raised by Glass regarding delivery timing. John indicated that the unit would be delivered 4-6 weeks fro m order. This would place delivery around the end of April.
- A question was raised by Lisiecki regarding the cost of taxes and license. John Kytasty indicated
  that there is no sales tax on the unit due to the club's tax exempt status. He also indicated that he
  unintentionally left off the cost for the license estimated to be \$250.00

A motion was made by Jerry Shiloff to authorize the spending not to exceed \$13250 for the purchase of the Race Trailer per the proposal

The motion was seconded by Mike Nienhuis Barber called for a Roll Call Vote.
