- Fall Colors Tarmac RallyCross (Nov 4) resubmission of one day budget for Milan – change in venue Discussion of price increase based on hourly rates Break-even is 70 cars and price increase for the location for updated budget Matt C moved approval and Piotr seconded and the budget was approved by voice vote
- Turkey Trot Tarmac RallyCross (Nov 18), Season Ender Tarmac RallyCross (Dec 9) Both at Milan and carbon copies Cap is 75-80
  - $\circ$  Started year with rate increase single day for \$60 is rate
