1. Old Business

- a. January BOD Meeting Minutes
 - i. Moved (JenG/Jerry) to approve revised minutes approved unanimously

2. Current Business

a. National Convention – Jen Glass and Jen Meredith will be attending for the region





3. Reports

a. Race

i. Bob Pierson reports that the Double National at Nelsons Ledgeds in July has requested support in Start and Grid. The concept of a restricted regional was discussed as a way to include non-SCCA classes, which could increase entry to a sustainable level.

b. Solo

i. Steve reported that the GLD Solo series schedule was released, and Detroit Region and Saginaw Valley Region will co-organize an event on July 18-19. Region solos will be mainly at Belle Isle. 8 events are planned. Steve recited the schedule, which is posted on the region website. Steve will schedule a Solo Planning Meeting to begin staffing the events.

c. Rally

- i. Ken reported that Dawnbuster is up next, on Feb. 21-22. It will consist of two regional rallies.
- ii. Ken submitted his directors budget. Moved (Jim/JenM) approved unanimously

- iv. Rallycross School Scott is investigating the possibility of organizing a rallycross school for the region this year.
