Race Report (Jerry for Bob) - Double National over 4<sup>th</sup> of July weekend, joint event with NeOhio. Great Lakes Division is organizing a Drivers School April 25-26 at Mid-Ohio. These are the only race events the region is involved with.

Solo Report (Jen for Steve) – Two events being added to calendar, to be run at Oscoda, an August weekend for Detroit Region event, July 18-19 for a divisional event

Rally – (Ken) – Son of Sno\*Drift lived up to its name, and was enjoyed by most competitors. 2009 Region Rally Championship rules have been posted on the website. Two changes were made. Number of rallies scored for championship points will be based on how many rallies are held. At the date of the last rally, competitors must be region members to be eligible for the region rally championship.

Rallycross (Scott) – First event is this Saturday at Crystal Motor Speedway. Jerry showed a drawing of the trophies (keeper and traveler) for the Thayer 2WD challenge. The Thayer 2WD Challenge will continue in 2009. Thayer is also the title sponsor for the 2009 Detroit Region Thayerautomotive.com RallyCross Series.

Treasurer – Jerry distributed year end financial information and a summary of the last nine years financial performance. The board discussed the financial struggles of Solo, mainly caused by high lot rentals. A new CPA has been retained for the region. We are still working to get the \$7000 refund from DTE for unused lot rental

Asst. RE - (Jen G) - A new meeting location was proposed, but after discussion, the board decided to stay at Doc's. Dave Allan will be granted permission to use the region logo for vinyl products for the region.

Membership (Rob) -1267 members as of 12/31/08. Membership fees will increase by \$5 next year. Referral program will be continued (\$15 for referrer, \$5 for referee)

Rallycross – Moved to approve (Jerry/Jim) - amended to add \$1000 for a laptop and printer, subtract \$500 for Thayer sponsorship, added \$275 for repair & main of timing equipment. – approved unanimously.

Registration – Moved to approve (Jim/Kyle) – approved unanimously

Treasurer – Moved to approve (Jim/Ken) – approved unamimously

Sound Control – Moved to approve (Jim/JenM) – approved unanimously

Race Director – Moved to approve (Jim/JenB) – amended to add \$2500 to fix axles and tires. – approved unanimously

Regional Executive – Moved to approve (Jerry/Brad) – approved unanimously

USRRC – Detroit region was approached to organize the 2009 US Road Rally Championship. Subsequently another region made a proposal that was accepted. The rally chairman will support organizers who wish to develop National rally or a rally weekend. The board will continue discussing this topic.

SPS Marketing – Move (Jerry/Kyle) to add banner ads from SPS Marketing (SCCA Gear Region Affiliate Program) to the region website – approved unanimously.
