HPDE Events – Hal reported that he is having discussions with Waterford. He has not contacted Grattan or Gingerman due to the distance from the Detroit area. (Note: after the meeting Hal sent an email indicating that WHRRI had 1 day in May, 2 days in June and 3 days in September 2007 available. There is also the possibility of piggy-backing onto the open track days – 1 each in May, June and September 2007.)

Reports:

Race – Hal Goff:

National Race – We have not received final accounting from FWR. We should have it by the August meeting.

Double Regional Race – We received a check for \$297.50 from the ambulance company for sending them back earlier than planned. This changes the net loss to \$4,649.

Michiana Drivers School – The event was very poorly attended as was the regional race held in conjunction with it. According to the preliminary accounting, our share of the loss is \$1,477. There is still a question about the WMR charge of \$1,000 for timing equipment use.

Drivers School – Hal is talking to WHRRI about the possibility of a joint school next year. He will have to contact National Office about membership/licensing recognition problems.

Special Events – Gary Godula (via telephone):

FSAE – Worker points were adjusted to eliminate the extra day's points for the Tech Seminar. Also, Road & Track used the facility for 2 hours after the FSAE event ended. DRSCCA is requesting reimbursement of \$250 for our time and equipment.

Solo – Angie Laney:

Pro Solo – June 25th in Washington DC: DRSCCA brought back 9 trophies.

Spring Fling – Same day as Pro Solo, but still had 194 paid entries and 187 timed cars.
