Call To Order at 7:01 by Rick Myers

Old Business

Minutes – Angie's solo report was provided by e-mail not phone. Move (Angie/Hal) to approve as amended – approved unanimously

Current Business

National Rallycross (Bob Martin) The event was successful. A final budget submitted. 33 cars participated, and the event made \$150. SCCA Headquarters wants to do it next year, but we need to agree on a date. Rental of thousandths reading rally clocks was required (current region equipment

Formula SAE – No report from event chairman. Other BOD members reported that the event went well, though entry to site was a problem.

Budgets

Oscoda Solo - Moved (Barb/Jerry) to approve – approved unanimously SVR/Detroit Solo - Moved (Keith/Barb) to approve – approved unanimously Rallycross at Bobs - Moved (Jerry/Barb) to approve - approved (Jen abstained) Crossroads Village Rallycross - Moved (Jerry/Dan) – Discussion: Event chairman confirmed that SVR supports the event – approved unanimously Gnu Rally - Moved (Angie/Keith) to approve – approved unanimously

Double Regional Race – Final Budget: 53 cars in attendance (120 budgeted) meant that revenues were significantly below projections. Only 6 licensed corner workers were in attendance. Because of the shortfall, event organizers made immediate and dramatic efforts to reduce expenses, including canceling the planned dinner, downsizing the party, cutting the trophy order, and borrowing radios. Unfortunately, the event still lost \$4949. The BOD discussed the situation, and all agree that the region needs to find ways to make money on regional races with lower car counts. Integrating High Performance Driving Experience (HPDE) events may be a way to do this. Reports

Race Report (Hal Goff) - National Race final budget in preparation. The event made a little money, but down from expectations. The rainy weekend resulted in several cancellations. There were no penalty for cancellations for this event, but that will change next year. Organizers had to recruit corner workers to meet minimums.

The Michiana drivers school is this weekend, with 24 entries booked. The region is committed to cover 1/4 of expenses.

Solo Report (Angie Laney) - Memorial Day Solo at DTE - 213 competitors participated and 1 new member was recruited. The next event is June 25 at GM Powertrain Ypsilanti plant. 10 Region members are going to DC Pro Solo that same weekend. 35 members attended the event at Peru. The Powertrain site going away next year.

Angie is still looking for Solo Director for next year.

Detroit Metro Airport may have a site for us next year, and City Airport is being investigated as well. Site acquisition is currently the biggest challenge facing the Solo program.

Treasurer's Report (Keith Roberts) - Keith reminds event chairs that last minute requests for checks may not be fulfilled in a timely manner. In these circumstances, expenses may have to be paid out of personal funds and be reimbursed by the region later.

Asst. RE Report (Barb Steencken) – Ideas for membership meetings are being solicited. Cauley Chevrolet would like to discuss holding region meetings at their facility, Barb will follow up.
