<u>Funmover Budget</u>: (Rick). Propose raising budget from \$500 to \$750 per event for usage per submitted financial analysis. Discussion tabled until insurance costs for Funmover and trailer can be reviewed further.

MTM Fire School (Ed Author and John Lisiecki). Proposed supporting funding split 60% WHRRI, 40% DR SCCA. School is projected for a \$2400 loss, \$1000 of which will be DR SCCA responsibility.

<u>Great Lakes Division Driver's School</u> (Rick). Project for \$7000 loss split between 7 regions with a \$1000 liability for DR. DR to provide sound equipment. Awaiting discussion with other participating regions.

Solo: (Carol Kolk). Solo Season Opener budget presented.

New Business:

<u>Hotline</u> (Jerry) – Jerry submitted costs for hotline operation. Proposed discontinuing both hotlines based on low call volume and high number of out-of-state calls. Discussion to continue on-line.
