- d. Proposed Sponsorship by Corvetteguys.com Kaleb Freeman from this organization is interested in sponsoring the region in exchange for web exposure. Monetary donation as well as t-shirts and part discounts are possible. Discussion will continue on the BOD Forum.
- e. Put-in-Bay Vintage Autocross Manley Ford of Sports Car Vintage Racing Assn. is interested in having us operate an autocross at an upcoming event to be held in Put-In-Bay. Most likely on the last Monday and Tuesday of June. Discussion will continue on the BOD Forum.
- f. Steve proposed eliminating the Funmover assessment in order to reduce the Solo entry fees, making the region events more cost competitive. Event entry





numbers have been down, and entry fees are perceived to be a reason. Motion: Rescind Funmover fee from Solo budgets for one year, and reduce Solo entry fees by \$5/entrant. Moved (Steve/Jim). Approved unanimously.
