Race Report - (Hal) - Hal will have National weekend at Grattan date confirmed before the upcoming Great Lakes Division roundtable.

Solo Report – (Angie) Final event was successful with 205 competitors. Palace will continue to work with us in 2007. Carrie Heiser was introduced to the board as candidate for Solo Director in 2007. Site acquisition is still a concern, and Angie is still working with site acquisition support from SCCA. 4 Detroit Region members won national championships at the Solo Nationals.

Rally Report – Bob Martin reported on recent rallycrosses – The Sept. event in Flint netted 27 entries. The site repair bill was higher than expected, so the event carried a slight loss. The Oct. event last weekend at Bobs Family Raceway netted 23 entries and made about \$200. Events scheduled for Flint in Nov. and Fowlerville for season ender in Dec. Registration is on myautoevents.com. Entries have been declining through the year, possibly because of how rough rallycrosses can be. Bob will be chairing rallycross discussion at GLD Roundtable

GLD Roundtable - Sun. Nov. 5 in Columbus, Rick, Bob, Jerry/Mary are going. Rick would like a strong showing from Detroit Region.

Detroit Grand Prix – Recent news reports indicate that the Detroit Grand Prix will return to Belle Isle in 2007. Rick will contact Bob Pierson to see if region resources will be needed/welcome at this event.

Detroit Region Decals - John Lentz made proposal to produce new 5 x 3.5 inch decals. John will take possession of current inventory of decals and patches.

Equipment maintenance/inspection - Fire extinguishers used at current events are correctly charged. Motion (Jerry/Hal) to complete needed funmover repairs (generator, etc.) be done (not to exceed \$1000), and to have the funmover be inspected at General RV after removal from storage was unanimously approved.
