2021 Taxes and Accountant Review - We had hoped to file by 15 May but a few items have come up. First, we had such a good year in 2021 that we can't file a 990-EZ and must now file a 990. This will increase our preparation costs \$150 (\$600 total) as the form is more detailed. Second, H.C. sent me a set of questions that didn't come through email so he resent them yesterday. Lastly, I found one last group of expenses booked in Jan-22 that related to 2021. I've let H.C. know about that issue.

Financials - That shift of expenses from 2022 to 2021 was about \$5k, so we had a surplus of about \$30k in 2021 which was better than 2019 and 2020. I've attached an income statement for YTD April 2022. We're at about a \$8k deficit which compares to a deficit of \$5k for YTD April 2021. As we discussed last month, our YTD 2022 deficit is driven by the banquet (money well spent). I also need to work with Frank on a few expenses to ensure I've categorized them properly. Profit and Loss statement shared

Earning more money on our money - I've been researching ways for us to get a better return on our money than 0.03%. Comerica doesn't seem to have other options until you have more than \$1M to work with. I also looked into switching from a basic checking account to an interest bearing checking account but the fees negate the interest earned. Bottom line, we would have to look outside of Comerica for alternative investments. I'd recommend we have a more detailed discussion at a future meeting regarding a potential investment committee to investigate further.
